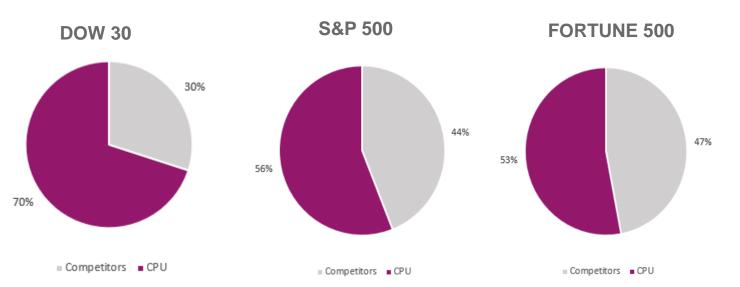

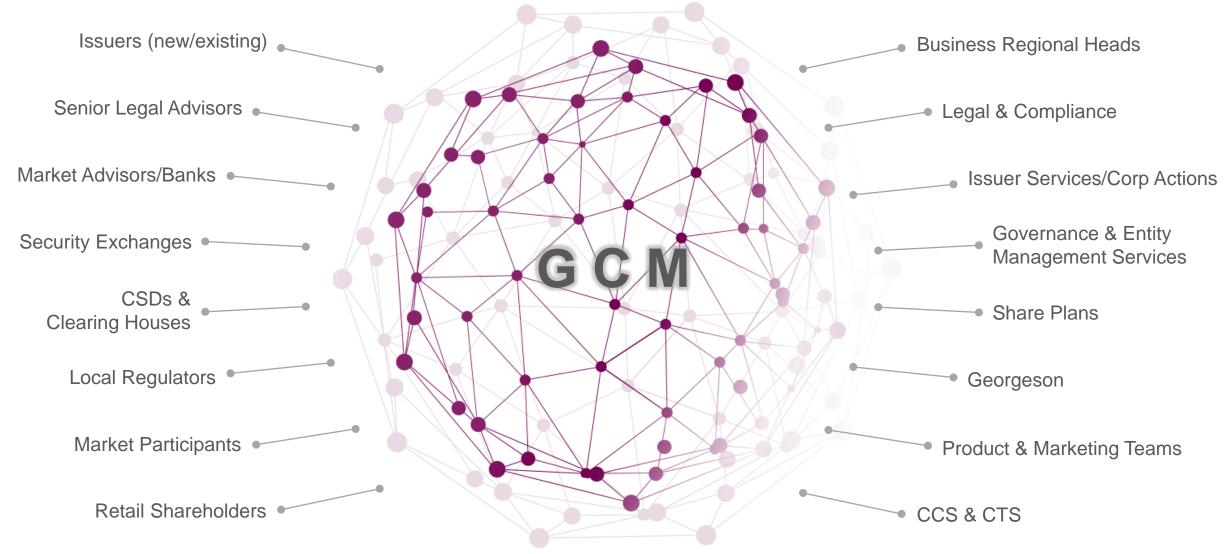
- Legal permissions/compatibility with home jurisdiction;
- > Speed and Cost to Market;
- > Precedent transactions (well known path or first of its kind);
- Stamp duty/transaction tax analysis for the project and ongoing Issuer/Investor transactions;
- Shareholder (cornerstone investors/controlling holders) demands and preferences;
- > Eligibility for major index inclusion;
- Complexity of future Issuer events (management of AGMs, Dividends, Buybacks, Corporate Actions etc.);
- Market changes (pending regulations, market infrastructure and settlement timings); and
- > Ability to create a fungible cross-listed security.

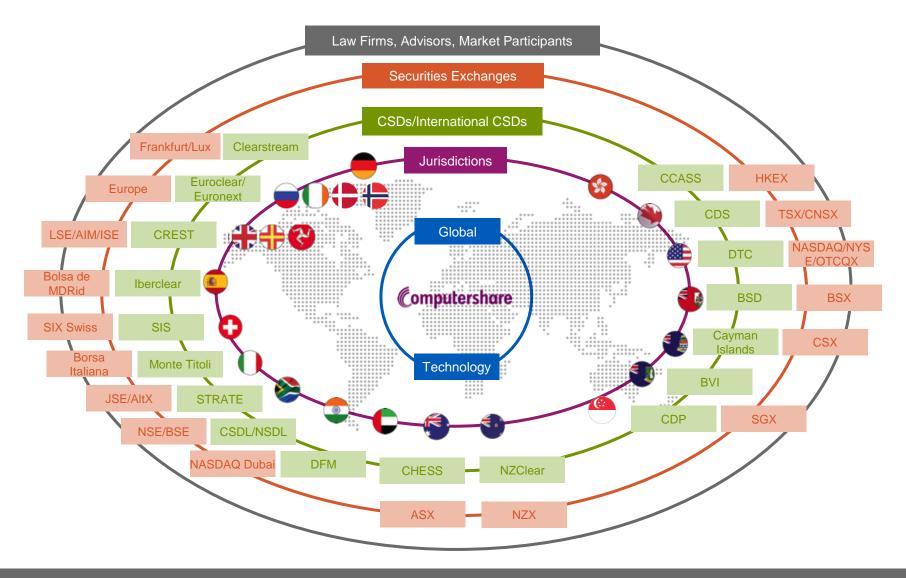
